

## Frequently Asked Questions

### **What does Vienna Business Agency look for in a startup?**

VBA judges look for startups, with a viable path to success and some traction in their local markets.

### **Do I have to be in Vienna for the entire one-month period?**

Vienna Startup Package does not require startups to work full time out of Vienna. We make sure that you have days where no program is scheduled. So, it's up to you to decide whether you want to stay in Vienna during that "free" days or not. However, it is highly recommended given the networking opportunities, and valuable encounters that come often by being present.

### **How do you proceed with the program during COVID?**

If the restrictions remain, we will consider a digital version.

### **How do you choose which startup to accept?**

Our diverse expert judges identify the best program startup fit.

### **Where will we live while we are in Vienna?**

We will provide a private room in a central location. The accommodation is booked only for one person/startup. Please note that we won't be able to promise any support for individual solutions in terms you want to travel to Vienna with your team members or with your family.

### **Where will we work while we are in Vienna?**

We will make sure that you have a flex desk in one of the coworking spaces in the city center or directly at your accommodation.

### **Can my cofounder travel with me?**

The additional costs due to attendance of a second person are not covered.

### **Do I need a travel health insurance?**

Vienna Business Agency provides a basic health insurance for the time of the offline program in Vienna. Please inform yourself whether additional travel insurance is necessary for your specific needs. Once accepted, we will share the agreement including the information for basic health insurance.

### **Who will arrange my travel?**

Once accepted, we ask you to book your own return ticket. Selected startups are entitled to have their travel expenses reimbursed up to 500 EUR within EU, and up to 1000 EUR outside of EU. The reimbursement of the travel costs will be processed after your arrival in Vienna. Please follow the reimbursement procedures shared by the team.

### **Will you help me with my visa application?**

Please make sure to clarify your visa situation as early as possible. Once accepted, we can provide you with a letter of acceptance if required. This was helpful in the past but can be different for your individual case. We recommend starting your visa process as soon as you have the confirmation.

### **Do you fund companies?**

Vienna Startup Package does not take any equity or provide investment to selected startups. Participants will be introduced to our grants during the program and might be eligible for one of those.

### **What is your policy on intellectual property protection?**

Protection of intellectual property rights (ex. patents, trademarks, copyright, trade secrets, etc.) of your concept is your responsibility alone. If you have an idea or product that you might want to patent, we strongly recommend speaking to a lawyer before submitting information about this idea to the application platform.

Information you include in your application will be shared with our expert judges, involved colleagues from Vienna Business Agency and with our scouting agency Leadspicker that reviews your application.
